PENHESGYN SITE DRAINAGE

CULVERT MAINTENANCE AND REPAIR - PENHESGYN LANDFILL**SITE INSPECTION AND COMPLIANCE UPDATE**

A follow up inspection of the surface water drainage system and culvert running under the landfill was undertaken to assess progress against actions stipulated in the previous CAR form NRW-0040554 dated 18th October 2022.

During a site inspection on the 18th of October 2022, it was noted that there are issues with the main culvert and silt trap running under the site the following actions were required for compliance:

Please complete the following actions by the 30th of November 2022

Improve the silt trap upstream of the culvert (see photo 2 below)

De-silt the area upstream of the silt trap and ensure de-silting occurs on a regular basis

Extend pipe and stabilise bank around culvert entrance (photo 1 below)

Conduct a camera survey of the existing culvert

Submit written summary of plans to improve culvert and silt management to NRW within 2 weeks of the date of this CAR form.

Progress has been made against all of the above actions and the improvement of the watershed drainage by the addition of interception ponds and improved field penetration increasing field capacity for water have made a huge difference to the flow of water and the flooding issues that have occurred regularly upstream of the culvert.

A culvert camera survey is due to be completed in May 2023 which will give an improved picture of how the culvert is faring structurally and whether there are blockages which need to be removed.
