We have received and reviewed the following monitoring reports for 2022;

Performance 1 / 26/04/12.

Comments;

Report received late on 31st March 2023 after a reminder was sent. This was due by 31st Jan 2022. Late reporting has been previously assessed as non-compliant for the operator and is recorded here as a **C4 breach** – with no potential for environmental impact.

Energy usage is up slightly overall and proportionally to production.

Food waste continues to go to AD and not landfill.

Dissolved Air Flotation plant is realising improvements to sewer discharge with no consent limits breached. This does need reviewing/inspecting from a DAA perspective, see below.

Actions;

Ensure reports are submitted by the required dates.

Additionally;

1. The boundary change will need a permit variation – outstanding action on Operator.
2. DAF plant - will need to understand if a permit variation is required. Please forward operating and maintenance procedures for assessment. – outstanding action on Operator.
