This CAR has been produced to acknowledge receipt of and approval of Knauf Insulation Limited's notification of electrostatic precipitator shut down and operation of the site's by-

pass stack.

The shut down and by-pass stack operation will take place between 14th May 2023 22:00 to 18th May 2023 22:00 for the purpose of undertaking maintenance and any necessary repairs identified during the previous shutdown inspection.

Measures taken, or intended to be taken, to rectify, limit or prevent any pollution of the environment which has been or may be caused by the emission are: Shut down and operation currently planned to tie in with a mainline 5 day shutdown meaning glass pull rate and furnace output will be reduced.

The above represents compliance with permit conditions 4.3.5, 3.1.1 and 3.1.2.
