4. Details of our assessment

EnerSys have installed a new, electric drying oven in Cell 3, the acid filling area. This operational change does not require a permit variation but must be agreed with Natural Resources Wales

(NRW).

Permit Condition 4.3.5 states -

"Where the operator proposes to make a change in the nature or functioning, or an extension of the activities, which may have consequences for the environment and the change is not otherwise the subject of an application for approval under the Regulations or this permit:

(a) Natural Resources Wales shall be notified at least 14 days before making the change; and

(b) the notification shall contain a description of the proposed change in operation."

CAR_NRW0040027 Action 6: Send a full description of all aspects of the proposed changes to NRW at least 14 days before the changes are likely to become operational.

NRW received the operating procedures and maintenance schedule for the oven on 18th January 2023. All the documentation was satisfactory. NRW have no objection to EnerSys using this oven.

Action 6 has been completed and can therefore be closed.

During this visit EnerSys mentioned that they were also planning to change the casting method in one of the oxide mills. NRW would like to know if this change was implemented and if so, what has been changed.
