Natural Resources Wales Environment officers Alex Tennant and Tony Bruten attended St Pierre Poultry Farm EPR/VP3832MZ on the 10/07/2019 at 1000hrs and were met by Mark Woskett who is the manager of the site. We were shown to the site office where a number of inspection checks were undertaken - including but not limited to - general management (inspection and maintenance, complaints, training, site security, permit, accident management plan, raw materials, water use, waste disposal), manure management, plans, records and emissions.

We then briefly inspected the outside of the poultry house and ventilation and drainage were seen - this was all in order. The rain/groundwater and slurry waste all drained into the same drainage tanks that were emptied a minimum of twice a year.

No breaches were identified and site was vacated at 1100hrs.
