In accordance with Permit Condition 2.3.6 Celsa Manufacturing UK Ltd. notified NRW by letter, received 1st March 2019, of the intention to use a mobile jaw crusher for the purposes of crushing and screening approx. 20 000t of oversize slag. The potential environmental impacts of the proposed activity have been assessed and NRW is content that the measures in place should ensure that any impact is insignificant. The activity will be carried out on the Mineral Site and is expected to continue for a period of four weeks.

In view of the occasional complaints that are received in respect of fugitive dust releases from the Mineral Site Celsa should be cautious to ensure such releases are abated as necessary. While there is no specific indication that fugitive dust releases from the Mineral Site will increase during the crushing and screening operations, Celsa should review the on-going performance of the equipment and take proactive measures if at any stage dust releases have the potential for off site impact. It will also be prudent to consider the contribution of the prevailing meteorological conditions, specifically wind speed and direction together with any extended dry periods..

If at any stage complaints related to fugitive dust and or noise are received NRW will need to review the permission that has been granted.
