Thank you for your time during the inspection. The inspection found that you are compliant with your permit. Following the review of your first visit we have identified some points that need amending and further documentation to be added.

Advisories –

We would advise that the Site Entrance Identification Notice that you have on the side of your unit be added at the entrance on the gate/fence.

Inspection and Maintenance – As discussed record damages and repairs. You suggested using a log book with each crop.

Public and complaints (4) and Odour (20) and Noise (21) – As suggested sign off the sheets to show what, if any complaints received in a period.

Energy – You have said you will commence recording and documenting your energy (electricity, solar, bio mass) that is used in the units, we recommend it is easier to do this per crop cycle.

Raw Materials – Ensure your list in your file shows chemicals actually used on site and not what potentially could be used, this is to be updated and a list appended to your accident/emergency plan.

Site Plan (23) – A copy of the site plan will be placed in the unit on the notice board showing an accurate representation of the site. Please see guidance (23)

Drainage management (25) – Your emergency plan stated the drainage plan is in the shed, this is to put up as discussed. Please see guidance (25)

As discussed outdoors with Mr Lloyd, feed silos - storage vessels for foodstuff should be protected from collision damage.

Raw Materials Containment – Any animal medicines, chemical etc should be contained in an area capable of retaining spillages. As discussed you will now use a bunded tank.

Please can the above be put in place within the next two months.

Please refer to the 'How to comply with your environmental permit for intensive farming' document, which clearly gives information on the required content for the reviews.

Aside from the above, we are content that you are compliant with your permit.

We discussed 'The Control of Pollution (Oil Storage) (Wales) Regulations 2016' on site and handed you a leaflet that explains what is needed to be done by 2020.
