### 4. Details of our assessment

This CAR form has been issued in response to the submission by Margam Green Energy Ltd of documents in response to Improvement Conditions (ICs) relating to the IED Waste Incineration Best Available Techniques (BAT) Reference Documents (BREF) and

associated BAT Conclusions. The review of the documents is outlined below.

### Improvement Conditions

IC10 This requires the operator to “*carry out a programme of dioxin monitoring over a period and frequency agreed with Natural Resources Wales. The operator shall submit a report to Natural Resources Wales with an analysis of whether dioxin emissions can be considered to be stable.*”

The operator has submitted an e-mail dated 30 March 2023 with an enclosed report ‘*Margam Green Energy Ltd, Analysis of August 2022 Elevated Dioxins and Furans Results*’ (Fichtner Consulting Engineers Ltd, 2023).

They report that extractive monitoring results for dioxins/furans have been consistently stable and within the permitted limits apart from the extractive sample taken in August 2022. The consulting engineers report identifies the likely root cause of this exceedance as excessive air ingress causing cooling, reducing flue gas temperature, and preventing the thermal destruction of dioxins/furans.

The source of the air ingress was identified as an incomplete seal between the riddling conveyor and burnout damper, fitted in May 2022. This was rectified in November 2022 and the subsequent dioxin/furan sampling round in December 2022 was within permitted limits.

The operator reports that this demonstrates that the levels of dioxin/furan emissions are ‘low and stable’.

**The submitted documents demonstrate compliance with the requirements of IC10 and the condition is discharged.**

IC11 This requires the operator to “*carry out a programme of mercury monitoring over a period and frequency agreed with Natural Resources Wales. The operator shall submit a report to Natural Resources Wales with an analysis of whether the waste feed to the plant can be proven to have a low and stable mercury content.*”

The date specified in the permit for fulfilment of this IC is “*30/09/23 or as agreed in writing with Natural Resources Wales*”. In order to obtain a further three triplicate samples, to complete six triplicate samples as required by the BREF, the operator has requested an extension until 31 December 2023 to accommodate

stack testing visits planned for June and October 2023.

**The extension is agreed.**
