Review of quarterly monitoring returns

Condition 4.2.3 requires that a report on emissions over the previous quarter shall be submitted within 28 days of the end of the reporting period. Quarter 1 (January - March 2023) returns were received within the reporting timescale.

Monitoring was undertaken in accordance with Condition 3.5.1.

Efficacy - all passed

Emissions to sewer - flow readings provided.

Air emissions monitoring

Emissions to air are monitored quarterly and the results were received on 27 April 2023.

Monitoring was undertaken as required by Condition 3.5.1. Emission levels are set by Condition 3.1.2 and Schedule 3 Table S3.1.

Q1 bioaerosol monitoring was undertaken on 01 March 2023. All results were below the ELVs specified within the permit.
