4. Details of our assessment

This Compliance Assessment Report (CAR) follows an unannounced offsite amenity assessment around the perimeter of the site.

At the time of the assessment, the weather was clear, warm and sunny. The site was operational and waste tipping activities were being carried out .

The roads near the site entrance were clean and there were no visible deposits on the road.

Officers detected a slight waste odour near the site boundary adjacent to the compost pad and a slight landfill gas odour in the vicinity of the north east site boundary. These odours were localised, transient and not considered significant. No other odours were observed during the course of the offsite assessment.

The operator is currently in the process of completing a programme of works to assess and, where necessary, upgrade the gas infrastructure to ensure the effective utilisation of landfill gas and reduce the potential for odours.

Officers observed a very small amount of waste material which had been blown onto the eastern flank of the landfill. This material was within the permitted boundary. Following this assessment, the operator confirmed that site staff are carrying out regular litter picks on the site.

Action 1- Action only- Ensure adequate covering materials are applied onto the active cell at the end of the working day to reduce the potential for odours and wind blown litter.

There was a small number of birds visible in the vicinity of the active cell.

No significant noise detected offsite.
