4. Details of our assessment

Condition 3.5.3 of the environmental permit states a topographical survey of the site referenced to ordnance datum shall be carried out:

(a) Years 1 and 2 post closure - annually,

(b) Year 3 onwards – every two years, and

(c) Review of frequency after Year 7 dependent on identification of changes in the landfill topography.

7 years has now passed since definite closure.

Action: Operator to review the frequency of topographical surveys and propose a frequency of topographical surveys going forward, along with the rationale for this by 10/07/2023.

Natural Resources Wales will then examine the proposal and rationale and, if possible, approve the proposed frequency.
