4. Details of our assessment

On Friday 5th May NRW Officer Chris BURGE attended at Olleco Cymru Wales, Stephenson St, Ind Est, Newquay Road, Newport NP19 4PL to conduct a routine site inspection. The weather was dry and sunny at the time of the inspection. Officer BURGE arrived at the site 10:30 and met with Site Manager Mr. Jason McCANN. Mr. McCANN kindly explained and guided us through the procedural activities at the Olleco site under permit BP3296EF.

Mr. McCANN showed Officer BURGE the area of the site to the rear of the offices. This area has been subject to a permit variation for the purposes of collecting and transporting food waste. The process is that Olleco vehicles collect the waste from the customer, it's then brought back to the site and transferred into larger trailers to be taken to the AD (Anaerobic Digestion) plant. Whilst this transfer takes place, a catch tray is placed under the vehicle (see photo 1) to make sure any waste that drops is captured. These trays are then emptied into the larger trailer.

Mr McCANN then took Officer BURGE to the other side of the operation. This area of the site is where the waste oil is brought to the site by vehicle where it is held within various types of storage containers. These are then emptied, and the oil undertakes a cleaning process. The site has sealed drainage and French drains on all exits to ensure nothing leaves the permitted boundary (see photos 2).

Whilst walking around the site a small section of the concrete pad was damaged within the oil recycling area. Mr. McCANN pointed this out to me and explained that there is a repair plan already in place, which will also include improving the drainage system on site, and work will be starting the week of the 9th of May 2023 (see photo 3)

Mr. McCANN then showed Officer BURGE the process of compacting the plastic containers once the oil has been removed. Mr. McCANN explained where all the different waste streams are taken. There were no offensive odours or noise witnessed by Officer BURGE during the site inspection.

Officer Chris BURGE was happy with the site and had no concerns or actions on this inspection, Officer Chris

BURGE left site at 11:30.
