### 4. Details of our assessment

This report details the site visit made on the 3rd May 2023 to A1 Skips, Newport, permit reference number EPR-FP3295FN.

NRW Officers Greg GARDNER and Carla CURTIS attended the A1 Skips site at Alexandra Docks, West Way Road, Newport, NP20 2UW for a routine site inspection at 11:00am where we met with the Site Manager / Owner, Mr. Lee COVELL. The weather was dry, and reasonably mild which it had also been the previous day.

#### **PERMIT BREACHES / ACTIONS**

No permit breaches / actions have been identified during this site inspection.

#### **GENERAL OBSERVATIONS**

The site was operational at the time of the site inspection.

#### **SITE INFRASTRUCTURE**

The general housekeeping on the site was in good condition with no major amounts of loose debris located on the floor (as seen in photo 1). The flooring infrastructure was generally in a good condition with only small areas requiring attention. It was noted that these areas will be addressed during the summer due to preferable weather conditions.

There was some movement of waste at the time of the inspection ensuring the housekeeping in the area remained of a good standard. The size of waste stockpiles on site were within compliance of the sites Fire Prevention and Mitigation Plan (FPMP) with no issues identified (as seen in photo 2 and photo 3). Further repair works are being undertaken with regards to the waste shed building to improve it's overall condition

Drainage on site is via an interceptor which was operational at the time of the inspection and cleaned periodically. There was no excessive noise along with no airborne dust present during the site inspection. There was also no offensive odours witnessed by NRW Officers.

### **SITE SECURITY**

During the previous site inspection (CAR\_NRW0040365), a concern was raised with Mr. COVELL regarding the poor condition of the site fencing (see photo 4). The site have installed new security fencing along the south section of the site (see photo 5). This will assist in the prevention of potential unauthorised person(s) to enter site.
