4. Details of our assessment

The non-compliance listed above was identified during our annual 2022 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Non-compliance in relation to: UV telemetry data - transmittance and lamps data missing in quarter 1. Missing data recorded on DCWW UV Fault Report "Telemetry fault meaning data had to be recovered from site. UVT and lamps on ratio missing." First notified of non-compliance on the 27/03/2022.

Actions – please carry out the actions specified above to comply with permit condition 3.3.10

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.

Please take the action required in this report as formal Advice and Guidance intended to bring the discharge back into compliance with the Permit.

Please note: this CAR is dated 31/12/22 as these non-compliances relate to annual 2022 data, however for clarity I carried out the compliance assessment on 11/05/2023.
