4. Details of our assessment

The non-compliance listed above was identified during our annual 2022 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

A late notification of a UWWTD sample reschedule date was received. A UWW sample was missed, dated 11/03/2022. A notification for reschedule of the sample was received 14/06/2022 (95 days from the original scheduled date). The late notification of the reschedule is a noncompliance under condition 3.3.8 of the permit, as this is not considered a reasonably practicable time scale for notification. This has been scored as a noncompliance with no potential environmental effect (c4)

Please note: this CAR is dated 31/12/22 as these non-compliances relate to annual 2022 data, however for clarity I carried out the compliance assessment on 28th April 2023.
