4. Details of our assessment

The non-compliance listed above was identified during our annual 2022 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

NRW checks identified a mix up with permit numbers. Had this not been identified, this had the potential to result in a permitted discharge not being monitored as per the permit requirements. NRW requested additional information and on this occasion have accepted no flow evidence previously not submitted.

Please note: this CAR is dated 31/12/22 as these non-compliances relate to annual 2022 data, however for clarity I carried out the compliance assessment on 28/4/2023.
