### 4. Details of our assessment

**\*\*Enforcement response changed so CAR re-issued \*\***

The non-compliance listed above was identified during our annual 2022 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Spot samples are to be collected at approximately equal intervals during the year, including samples from different days of the week and different times. The sample results provided by DCWW are dated 14/02, 25/03, 09/08 & 21/12. The sample frequencies are not approximately equal through the year, as a large amount of year is missed. This is classed as a noncompliance under the condition 3.3.5 of the permit, which could have a minor impact on the environment.

Please note: this CAR is dated 31/12/22 as these non-compliances relate to annual 2022 data, however for clarity I carried out the compliance assessment on 28th April 2023
