4. Details of our assessment

The non-compliance listed above was identified during our annual 2022 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

UWW samples taken were not evenly spread throughout the year. Within the 4 samples required, no samples taken during Q2 of the year. The sample frequencies are not approximately equal through the year, as a large amount of year is missed. This is classed as a noncompliance under the permit condition 3.1.2, which could have a minor impact on the environment

Please note: this CAR is dated 31/12/22 as these non-compliances relate to annual 2022 data, however for clarity I carried out the compliance assessment on 28th April 2023.
