4. Details of our assessment

The non-compliance listed above was identified during our annual 2022 data audit. This audit assessed Dŵr

Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Non-compliance in relation to: Efficacy monitoring shortfall: Sample dated 06/10/2022 missing Enterococci result and sample dated 17/11/2022 missing Faecal Coliforms result.

Actions – please carry out the actions specified above to comply with permit condition 3.3 Table S3.5

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.

Please note: this CAR is dated 31/12/22 as these non-compliances relate to annual 2022 data, however for clarity I carried out the compliance assessment on 11/05/2023.

We have issued a **warning** as a response to the above offence on this occasion.
