4. Details of our assessment

The non-compliances listed below were identified during our annual 2022 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

- 20 (b) | (c) UV telemetry data - transmittance and lamps data missing in quarter 1.
- 20 (c) | UV telemetry data reporting - missing transmittance and lamps data missing in quarter 1 not reported in the UV Fault Report.
- 20 (b) | (c) UV telemetry data - lamps data missing in quarter 2.
- 20 (c) | UV telemetry data reporting - lamps data missing in quarter 2 not reported in the UV Fault Report.

Please note: this CAR is dated 31/12/22 as these non-compliances relate to annual 2022 data, however for clarity I carried out the compliance assessment on 11/05/2023.
