Sampling shortfall for UWWTD, 1 result for BOD missing.

Efficacy monitoring shortfall: 1 complete sample missing (7 samples required between 09/04/2022 and 31/10/2022, sample dated 31/03/2022 discounted as not in seasonal window).

The non-compliances listed above were identified during our annual 2022 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/22 as these non-compliances relate to annual 2022 data, however for clarity I carried out the compliance assessment on 03/05/2023.
