4. Details of our assessment

An unannounced, routine inspection was carried out on 5 May 2023. I was accompanied by Non Harries, Business Manager and Andrew Nicholas TCM.

A small quantity of mattresses and a wood pile were being stored on hardstanding and not within a container. The wood was about to be loaded for removal off site.

B4 Containment of stored materials Category 3 breach

This is a breach of condition 1.1.1 The operator shall manage and operate the activities:

- a. In accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints

Section 8.1 of the EMS states that waste stored on hardstanding shall be in covered containers.

Action please ensure waste is stored within covered containers.

Correspondence is ongoing with regard to the transfer of the permit.
