4. Details of our assessment

Annual Monitoring Data

Permit condition 3.1 requires that the operator will undertake the monitoring specified in table 3.1. Table 3.1 requires that Annual monitoring will be undertaken on engine stacks.

The monitoring data was received on the 25th April 2023 following an agreed extension. No emissions limits breaches were detected.

It has been noted that that the Carbon Monoxide result was 605 mg/m³ compared to the permitted emission limit value 1400 mg/m³ and the result for total volatile organic compounds including methane was 860 mg/m³ compared to the permitted emission limit value 1000 mg/m³.

Whilst these results are not in breach of the environmental permit, they indicate inefficient and incomplete combustion of the fuel.

Actions

1. Carry out an investigation into the fuel efficiency of the sites MCP, including whether improvements to the fuel efficiency can be made and provide an update to NRW by the 16th June 2023.
2. In future reports, include units for the values in the Results section.

The operator is also reminded that air monitoring for 2023 should be performed by the 31st of December 2023. Data should be submitted to Natural Resources Wales by the 31st January 2024 in accordance with permit condition 3.5.2.

No breaches have been applied.
