A routine, unannounced visit was made on the 5 May 2023. The weather was wet.

The site was well signposted, and waste well sorted.

The site infrastructure was in excellent condition.

Site drainage was seen to be working well with surface water draining freely to sealed tank.

The oil storage container appeared to be full which resulted in many containers of oil being left on the floor waiting to be emptied into a new container.

ACTION Please provide NRW with an up-to-date copy of the EMS and continuing competency document for the site Technical Competent Manager (TCM).
