4. Details of our assessment

A site inspection took place on Friday 5th May.
Waste Regulation Officer, Sarah Walton, met with Landlord of the site, Dewi Roberts.
This was a pre-arranged meeting to discuss waste remaining on site and how the permit will be managed going forward.

The site looked to be in a similar state to the previous inspection. There did not appear to be any new waste on site. The waste that had been brought on site by GTR was still there, now with some weeds and other plant material growing on them. This evidences that the waste has not been moved in some time. The gates remained closed, with no operations taking place.

The operator of the permit does not have full access to the site anymore and there is no technically competent persons assigned to the premises.

NRW has attempted to liaise with the operator and informed them on a number of occasions, that they remain legally responsible for permit compliance. However, the operator has failed to claim any responsibility for the site permit.

Permit Condition 2.4.1: The operator shall complete the improvements specified in schedule 1 table S1.3 by the date specified in that table unless otherwise agreed in writing by Natural Resources Wales.

As part of the NRW led permit variation, the operator was required to complete improvements noted in Schedule 1, table S1.3. This included the production of an Environmental Management System, Fire Prevention & Mitigation Plan and Odour Management Plan. These documents should have been submitted 3 months from the date of permit issue (permit issued 1st August 2022).

These documents have still not been submitted by the operator. Through not submitting these documents, the site has been scored a CCS score 3 for this permit breach. As the site is not currently operating, this has the potential to cause a minor environmental effect.

Given the above matters, NRW is now continuing to progress with an application to revoke the permit from site.

The remaining waste on site has been brought on under the permit held by GTR. As a result, it is GTR's responsibility to remove this waste from site.

NRW has performed some sampling of these wastes. Please get in touch with the Regulating Officer prior to removing this waste from site.
