4. Details of our assessment

On Wednesday 11th May 2023 Ian Thomas, Waste Regulation Officer accompanied Hazardous Waste Regulation Officer Kathryn Bradshaw on an unannounced site inspection.

We were met by Paul Roberts, Environmental Compliance Officer for the company and he took us on a tour of the site. The site only accepts one waste stream, waste print toner cartridges.

The permit allows for material recycling, accepting printer toner cartridges for re-purposing and re-use. All waste accepted under the permit were stored and treated in accordance with the permit, Most cartridges accepted on the site are reused. Any that have been either reused too many times or are not in an adequate condition are stripped of useful parts before being disposed of. The site was clean, tidy and well organised both inside and outside of the building.

We checked copies of all waste transfer notes and trans frontier shipment notes and all were completed correctly with no issues found.

The site was undergoing some changes as they are looking at accepting printer cartridges containing ink and areas were being cleared to install the relevant equipment to process this new waste stream.

Currently the site has a number of waste exemptions registered and a separate email has been sent explaining the changes to the waste exemption regime and the need to review the site permit to ensure all activities and waste streams will be covered when the changes to the exemptions come into effect.
