4. Details of our assessment

On Tuesday the 2nd of May 2023 waste regulation officers attended at Lelo metal recycling Ltd. This was a planned unannounced site inspection.

The officers met Gari Jones, site manager and TCM and Matt Bellis.

Officers discussed the activities currently taking place on site.

The manager stated that inert waste is being brought in, but no waste is currently being removed.

Tyres stored on site

An action to remove all remaining tyres from site was given after previous inspections. The action has not been completed.

This issue has been raised with the management on previous occasions and was subsequently scored against relevant permit condition as a C3 breach.

A good progress was noted with the removal of the tyres, but some remain in the far corner of the site. This has been discussed with the manager and agreed that a removal notice will be served on the company.

The notice will be sent separately.

Action: Please remove/dispose of the tyres currently stored in the far corner of the site by the **3rd of August**.

Site Environment Management System - EMS

It was noted that storage arrangements are not as described in the site's EMS, also certain infrastructure has not yet been put in place i.e. storage bays, weighbridge.

Action: Please ensure your activities, infrastructure and storage areas are as described in the EMS or submit an updated version of EMS for assessment. Please comply by **3rd of August 2023**
