4. Details of our assessment

On Tuesday the 2nd of May 2023 waste regulation officers attended at Lelo metal recycling Ltd. This was a planned unannounced site inspection.

The officers met Gari Jones, site manager and TCM and Matt Bellis.

The site looked tidy; the internal storage was well organised with several waste streams stored in separate containers.

Storage, handling labelling and Segregation

Waste from Electrical and Electronic Equipment - WEEE

A number of WEEE items were seen on site mixed with other waste streams.

The site benefits from an S2 exemption which requires all waste accepted under its conditions to be kept separate and not treated on site. This issue has been raised during previous site inspections.

This has subsequently been scored against the below permit condition.

Permit condition 2.3.2 Waste shall only be accepted if: (a) it is of a type and quantity listed in schedule 2 table S2.1

Action: Please ensure all waste accepted under Exemption S2 - WEEE - is stored separately and not treated on site. **For immediate compliance**
