4. Details of our assessment

On Wednesday the 3rd of May 2023 the site's new regulating officer Ian Thomas and Boguslaw Pierzchala, waste regulating officer, carried out an unannounced site inspection at Bagillt Car Spares.

The weather was fine and dry.

During the inspection officers were accompanied by the site manager.

The yard was quite full with a number of ELVs stored on both permeable and impermeable surfaces.

Several depolluted vehicles stored on permeable ground were checked and officers did not observe any issues.

It was noted that a number of engines and oily vehicle parts were stored outside, some by the entrance to the depollution area. Please see the photos below.

It was discussed with the manager that such parts need to be either kept indoors or in a suitable container with weatherproof cover.

Action: Please ensure vehicle engines and parts containing oil or traces of oil are stored appropriately. Please comply by 26th of May.

Officers also noted a small oil spill at the entrance to the depollution area.

This was attended to by one of the employees before officers left the site.
