4. Details of our assessment

On Wednesday the 3rd of May 2023 waste regulation officers attended the site to conduct a routine site inspection. It was a planned unannounced visit to introduce the new regulating officer, Ian Thomas.

The day was dry and sunny.

The site was operational with operatives performing their duties.

NRW officers were accompanied by the site manager and the waste supervisor.

The site is well organised and well run. Customers benefit from a "meet and greet" procedure which helps with correct disposal of waste.

The officers assessed noise levels, deposit on roads, pests and odour with no issues identified.

Storage

As the officers walked around the site it was noticed that Waste from Electrical and Electronic Equipment - WEEE - was correctly separated; however it was not covered and exposed to the elements.

Technical requirements in accordance with Article 6(3)

1. Sites for storage (including temporary storage) of WEEE prior to their treatment (without prejudice to the requirements of Council Directive 1999/31/EC):

- Impermeable surfaces for appropriate areas with the provision of spillage collection facilities and, where appropriate, decanters and cleanser-degreasers
- Weatherproof covering for appropriate areas

It was mentioned that a three sided storage could be constructed in the future as it would be easier for the customers to use.

Action: Please ensure WEEE is stored in appropriate containers with a weatherproof cover. Please comply by the 26 of May 2023.

The site benefits from CCTV cameras as well as a security guard when the site is not operational.
