### 4. Details of our assessment

## Aluminium Breach - South Caernarfon Creamery

A schedule 5 notification has shown a breach of permit limit for effluent discharge from your facility into to the Afon Erch. The breach in question on this occasion is for Aluminium. This breach was sampled on the 10/05/2023

Permit condition 3.1 states:

**3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.**

**3.1.2 The limits given in schedule 3 shall not be exceeded.**

The limit for Aluminium is 1.0 mg/l and the value reported was 1.45mg/l.

The result is over the permitted limit and is therefore in the context of this discharge is considered a minor breach.

**The CCS score on this occasion is a CCS 3.**

**ACTION:** Repeat sample and check process parameters for any issues

**NOTE:** The breach was submitted to NRW 5 days after sampling. This is not within the required reporting timeframe and all future reports should be submitted according to permit requirements. Failure to do so may result in additional scoring.
