4. Details of our assessment

Aluminium failure on the 21/4/23 of 1.16mg/l and Aluminium failure on the 24/4/23 of 1.23mg/l.

Limit on the permit is 1mg/l

24/04/2023 = original OSM programme scheduled sample (taken on the pre-planned date)

08/02/2023 = original OSM programme scheduled sample. This sample was registered as a No Flow Event and a new rescheduled date was requested from Sampling. The date provided was the 21/04/2023.

Response from Lisa Elworthy, DCWW -

Due to the set up of site we are unable to isolate the lagoons in order to undertake sufficient maintenance, this has resulted in increased settled deposits and reduced settlement times. We have explored the feasibility of discharging our trade effluent to sewer however this is not possible due to the volumes anticipated, with similar blockers for tankering the flow.

As previously mentioned we have a Capital supernatant return scheme for Bretton WTW which would see all backwash and trade effluent recycled to the head of the works, effectively rendering this a dry site. I've received confirmation from Capital that we have been given authorisation to proceed with the scheme. Detailed design has been completed with the aim of starting construction this year with commissioning and handover of the scheme by the end of 2024.
