4. Details of our assessment

PERMIT BREACH FOR SUSPENDED SOLIDS

A Schedule 5 notification has shown a breach of permit limit for effluent discharge from your facility into the Afon Erch. The breach in question on this occasion is for suspended solids. This breach was sampled on the 19th April 2023

Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for suspended solids is 30mg/l and the value reported was 37 mg/l

The Suspended Solids result is in breach of the permitted limit and in the context of this discharge considered a minor breach, CCS3.
