4. Details of our assessment

On the 4th of April 2023, Dwr Cymru self reported a spill from this pumping station due to a sewer blockage. Unfortunately the spill had lead to a growth of sewage fungus downstream of the discharge into the small stream upstream of the Afon Seiont. The presence of sewage fungus suggests that this discharge had been going for a little while.

It's understood that the weather before the incident was wet. It's believed that this wet weather may have misled Dwr Cymru into thinking that the discharge was due to storm conditions.

It's noted that the permit to discharge for this site allows for discharges in an emergency, including due to downstream sewer blockages. If it wasn't for this condition, this CAR form would have been more firm in its enforcement etc.

It's understood that since the incident, action has been taken to complex the alarms at the pumping station in an effort to prevent further spills. Thank you for this.

Is there anything else that needs considering as a follow up to this incident? For example the condition of the sewer, or the type of material that caused the blockage?
