I attended Glangwden Poultry Unit on the 22nd May 2023 at 10:45, site inspection was carried out during production stage.

The inspection found that you were largely compliant with your permit. As discussed on

site please amend/provide the following -

1. Public and complaints (No 4) I would suggest having a record complaints per each year and sign and date at the end of the year.

2. Energy (No7) Add monthly Solar production/uses to records.

3.Site Plan (No. 23) - Permit site layout plan you currently have is needs to be updated - The site plan layout should be an accurate representation of the site (including clean and dirty water drains and storage). It should show external features such as roads. All site buildings and structures should be accurately shown and the installation boundary should be clearly marked. A very good plan should be to scale with north marked and be available both internally and externally at all times.

4. Please be advised that the site map within the permit, needs to be corrected.

We discussed collision barriers for feed silos, this may be achieved by the provision of kerbs, markers or barriers.
