4. Details of our assessment

This Compliance Assessment Report follows a site inspection at Bryn Lane MRF and Composting Facility, undertaken on 10 May 2023 by Rebecca Harwood, accompanied by Ian Thomas from the Waste Regulation Team.

Garry Smith (PFI General Manager), Thomas Bellis (Assistant Operations Manager) and George Newman (Assistant Operations Manager) were in attendance during the visit.

The MRF was operational at the time of the visit and no specific actions relating to its operation were noted. The IVC was not inspected.

A discussion was held relating to the movement of compost from Bryn Lane (after it has been through the IVC process) to the Llanddulas composting site in order to achieve PAS100. The Operators current end point (Gowy Composting Facility) is closing. The Operator has submitted a permit variation to NRW to include an additional waste code at Llanddulas following an Environment Agency and subsequent NRW decision regarding coding of the IVC compost post IVC treatment. This variation has yet to be determined and an interim position maybe required.

Bio-aerosol monitoring

Bio-aerosol monitoring was undertaken in accordance with Condition 3.7.1. The permit requires bioaerosol monitoring to be undertaken twice a year.

Table S3.1 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m³
- Aspergillus fumigatus - 500 cfu/m³
- Gram negative - 300 cfu/m³

Results from 13 April 2023 were received on 27 April 2023. Bio-aerosol concentrations were compliant at all sampling locations during this monitoring exercise.
