4. Details of our assessment

This Compliance Assessment Report follows a site inspection at Phase 2 - Wrexham Recycling Park undertaken on 10 May 2023 by Rebecca Harwood, accompanied by Ian Thomas from the Waste Regulation Team.

Garry Smith (PFI General Manager), Thomas Bellis (Assistant Operations Manager) and George Newman (Assistant Operations Manager) were in attendance during the visit.

The MBT was operational at the time of the visit and no specific actions relating to its operation were noted. The Operator stated that a new fire suppression system had been installed, including a new water tank.

Action: The FPMP is currently being updated and should be forwarded to NRW once completed.

Following agreement to trial the removal of the acid scrubber, the dosing system was isolated in April 2023. Quarterly ammonia monitoring is being undertaken as agreed in NRW's letter to the Operator dated 14 September 2021. The Operator has stated that if ammonia limits exceed 5mg/m³ then the acid would be reinstated.

Advice and Guidance: The Operator should ensure that all elements of the agreement are being followed.

A discussion was held relating to POPs in bulky waste and the Operator raised concerns relating to the implementation of the regulations at the site. This has been raised with NRW's policy team and NRW will liaise with the Operator separately.

Bio-aerosol monitoring

Bio-aerosol monitoring was undertaken in accordance with Condition 3.5.1. The permit requires bioaerosol monitoring to be undertaken twice a year.

Monitoring was undertaken on 13 April 2023 and the results submitted to NRW on 27 April

2023.

Table S3.4 specifies limits for bio-aerosol concentrations as:

- Total bacteria (TB) - 1000 cfu/m³
- Aspergillus fumigatus (AF) - 500 cfu/m³

Bio-aerosol concentrations were below the above limits at all sampling locations during this monitoring exercise.
