4. Details of our assessment

Officers Chris Burge attended at Berthgron Quarry Transfer Station, Nelson to complete a routine compliance inspection of the permit EPR/UP3695FZ held by Valley Recycling Limited. Weather was cool and dry at the time of the inspection. Officer Chris Burge met with site manager, Mr Lyn Bowen, who showed the officer around the facility.

The visit consisted of an inspection of the permitted area and a discussion in the site office regarding duty of care paperwork and site management documents

Inspection

The site was organised and appeared well managed at the time of the inspection. Incoming waste streams were clearly stored in individual bays or the appropriate skips after being sorted by plant machinery or by hand on site. It was noted that the site had been relatively quiet recently, with incoming skips typically processed very quickly. No crushing equipment was active at the time of the inspection. However, Mr Bowen clearly explained the management of crushing activities when operational. The several stockpiles of inert wastes awaiting crushing/stockpiles of processed aggregates were clearly segregated and contained minimal contamination. Mr Bowen explained that processed aggregates were exported from site as product, as the site processes the waste in accordance with the WRAP Quality Protocol for production of aggregates from inert waste.

A copy of the operator's quality management document for this process was available in the site office.
