4. Details of our assessment

Sample taken on the 15/5/23 had suspended solids result of 162mg/l.

The permit limit is 50mg/l LUT

Based on the LuT and the site's sampling frequency, this result is classed as a LuT Exceedance. This means that is within the allowable number of exceedances using the look up table

Response from DCWW -

We have had another high solids sample(self-reported following escalation), BOD and ammonia both fine showing the biological process was still performing. This time we did find a significant amount of FOG that had come into the works and we are investigating the incident
