4. Details of our assessment

Natural Resources Wales (NRW) officers Paul Challender and Stuart Ross attended Chirk as they had been informed that Kronospan intended to conduct a site wide shutdown from Monday 15th May 2023 to Wednesday 16th May 2023.

During the officers time in Chirk, it could be heard that Kronospan was in shutdown however, some activities were audibly operational. The officers took measurements with a class 1

sound level meter throughout their deployment at various locations.

The sounds detected from Kronospan were subjectively perceived with elements that could be described as tonal, impulsive and intermittent. There was also a contribution of industrial sound from an adjacent facility which, appeared to be both broadband and tonal.

The sounds emitted from Kronospan consisted of the pulse air jets which, had remained operational. In addition, fork lift trucks (FLT) operating in the despatch area could be heard. This included engine noise, horn use, reversing alarm use and the sound of the forks banging as FLT moved around the area. The officers were able to perceive the movements of the diesel FLT over and above the movements of the electric FLT.

Furthermore, an unidentified, intermittent squeak could be perceived from what appeared to be the rear of the Kronospan site. The source of this noise has not previously been observed by NRW.

Consideration will be given to the two recent night time visits to Chirk (site on/site off) and inform our forthcoming audit of the recently submitted Noise Management Plan (Improvement Condition 40).
