4. Details of our assessment

This Compliance Assessment Report follows an Operator Monitoring Assessment (OMA) Audit completed 31/03/23.

The audit covered, for the first time, emissions to air from release points A26 (K7 Biomass Boiler), A27 (K8 Biomass Boiler), A29 (MDF 2 Dryer Cyclones), A30 (MDF 1 Dryer Cyclones), A31 (Press Abatement) & A32 (WESP 21 / Dryer No.4).

This report shall be read in conjunction with the OMA audit report form where the detailed findings/observations are recorded. Any permit non compliance and associated actions are listed below. The audit report also includes a number of other actions that should be met (not listed here).

1. Emission Point A27 (Biomass Boiler K8) - EN14181

As detailed in Section 3 of the OMA report, and contrary to permit condition 3.6.1, the operator had not completed a QAL2 exercise until March 2023. The CEMS have not been subject to Annual Surveillance Testing (AST).

The root cause of this non compliance is inadequate monitoring procedures and is in breach of permit condition 1.1.1.

The operator had identified this issue prior to the OMA and commissioned a QAL2 exercise for both sets of CEMS December 2022. Both CEMS passed and following this audit calibration functions have been entered into the Data Acquisition and Handling System.

The CEMS have been subject to QAL3.

NRW considers that these breaches have the potential for a minor environmental impact and a non compliance score of C3 is awarded for each breach of condition.

Action 1 – Review existing monitoring procedures against the requirements of EN14181 (also refer to Environment Agency Technical Guidance Note M20 ‘Quality assurance of continuous emissions monitoring systems - application of EN 14181’) and amend accordingly to ensure that the requirements of the standard and your permit are met in full. Provide NRW with a copy of the amended procedure by 31/07/23.
