4. Details of our assessment

Fugitive Emissions Report 2022.

Cabot submitted a Fugitive Emissions report for 2022 in support of reporting requirements under permit requirement 4.1.4. The report addresses fugitive emissions from the installation to air, water and to land.

No emissions of a significant nature were recorded in 2022. The majority of spills were contained within the site's secondary containment and indoor areas or were minor spill amounts.

In 2022 there were 28 releases recorded across 11 media categories totalling 546Kg. The table below displays the fugitive releases in 2022.

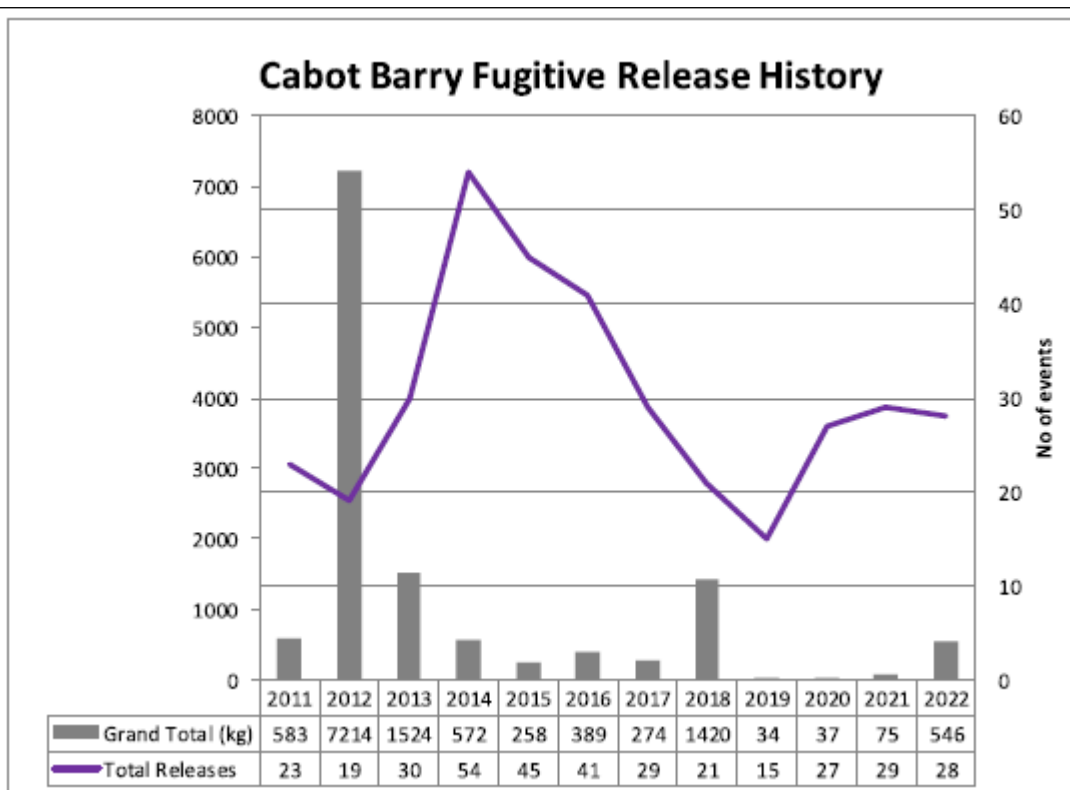

The release of 300 kg of Anhydrous Hydrogen Chloride (AHCl) was from a leak from a by-pass control valve. Investigation by Cabot determined that the leak was a result of a hole in a PTFE bellow.

The fumed silica release from a tanker loading operation (170 kg) was a result of a number of human errors.

The graph below shows Cabots fugitive release history.



As part of Cabots sustainability 2025 goals Cabot has implemented a process management scorecard to help Cabot to reach its goal of reducing significant process safety events by 50%. The loss of primary containment is now classified as a process safety event and now directly impacts the continuous improvement activities aimed at reducing fugitive emissions. NRW supports this drive and ambition at Cabot to reduce process safety events, fugitive emissions and their corporate drive to zero ambition.
