4. Details of our assessment

A site inspection was undertaken on Friday 19th May 2023 by Natural Resources Wales regulatory officer, David Morgan.

The inspection was prompted as the operator intends to partially surrender the Environmental Permit (ref: EPR/PB3490HV). The permit boundary will be amended and an area of the site (now utilised as a car park) will be removed from the permitted area prior to the land being released to the landowner (Port Authority).

As well as assessing the area prior to the surrender, other aspects of the permitted operation were assessed in line with the Environmental Permit for the site. The following observations were made:

Permit Surrender Area

In the initial application, it was suggested by the applicant that this area (car park) did not form part of waste storage activities, however, Natural Resources Wales records indicate that waste was stored in this area by the previous operator in 2016.

A thorough inspection of this area was undertaken and I can confirm that operations dating back to 2016 do not appear to have had a lasting impact on the site. No waste was being stored in this area and there were no signs of any impact from operations (such as staining on site surface from leachate etc.). Operations do not appear to have had any impact on this area. As a result, the risk to the environment is sufficiently low so intrusive surveying/monitoring is not required and it would appear that a 'Low Risk Surrender' is appropriate, should other criteria in the application be fulfilled.

Permitted Waste Operations

An inspection of the site was undertaken. From initial observations, the site appeared to be very well managed and maintained to a high standard.

All waste was clearly segregated. Outside of the buildings, there was no signs of litter/waste escaping the storage/bulking operations on site.

Given the waste types and location of the site, there were very few birds/pests (gulls) and it was deemed that pests were not having an impact on operations or the local amenity.

It was noted that food waste is loaded directly into a trailer and removed from site. Staff (Nigel Cole, Technical Competent Manager) had a thorough understanding of the

procedures for dealing with accidental spillages/leaks if/when they occurred. The area appeared to be free from any spillages from deposits of food waste.

Generally, operations did not appear to be having any detrimental impact on the local amenity. No significant odours, noise, pests or deposits on the road were noticed off site and general housekeeping was of a high standard.

Following an inspection of the site, up to date copies of the Environmental Permit and Environment Management System (EMS) were made available for inspection.

Summary

Waste operations that took place in 2016 do not appear to have had a lasting impact on the area of the site that is being surrendered. Therefore, a low risk surrender appears appropriate.

An inspection of the site was undertaken and all aspects of the permitted operation that were assessed appeared to be compliant with the Environmental Permit.

No non-compliances were recorded during the inspection.
