The main purpose of the Runtech Limited (Runtech) activities at the Port Talbot installation are to serve the Tata Steel UK Limited (TSUK) steelworks processes (EPR/ BL7108IM). These activities are directly associated with steel production and include scarfing of steel slabs.

The operator submitted the Q1 2023 monitoring returns on the 27th April 2023, which is within the specified reporting window, representing compliance with the permit condition (4.2.3).

The permit requires the operator to monitor the following parameters on a quarterly basis:

Emissions monitoring demonstrates that the emission limit of 10 mg/m3 at AS 1 (Scarfig air filtration plant) was not exceeded throughout the reporting period.
