4. Details of our assessment

A site inspection was conducted on Thursday 1st June 2023. The purpose of the visit was to assess compliance with the Regulation 36 Notice that had been served on Tegfan Recycling, requiring that infrastructure on site (namely boundary fencing) be improved to prevent waste escaping site and entering a nearby stream.

Please accept this Compliance Assessment Report as formal acknowledgement that on Thursday 1st June 2023, Tegfan Recycling were deemed to have complied with the notice.

Present during the inspection on Thursday 1st June were David Morgan (Natural Resources Wales) and Laura Terry (Tegfan Recycling).

Infrastructure

In previous inspections, Natural Resources Wales had highlighted concerns regarding damaged boundary fencing which was failing to prevent waste from escaping site. Some materials (bricks, stone) had fallen off the site and entered a stream.

This appeared to be localised and did not result in a significant pollution, however, works were required to prevent waste escaping site.

On Thursday 1st June 2023, this work appeared to have been undertaken and infrastructure has improved. It has been noted that temporary fencing has been erected with the intention of installing a concrete wall all along the boundary. All waste from outside the site boundary had been removed and Tegfan Recycling was deemed to have complied with the notice.

On the date of the inspection, Natural Resources Wales considered Tegfan Recycling to be compliant with condition 2.4.1 of the Environmental Permit (B4 - Infrastructure - containment of stored materials).

This now concludes this matter. No further action will be taken at this time. Please ensure the boundary fencing is regularly checked and maintained to prevent escape of waste from site.
