4. Details of our assessment

NRW Environment officers Nathan Owen, Cathrine Kiely accompanied by NRW officer Gareth Siney, on the 25/05/2023 visited the Llangernyw STW on the day we were escorted by Michaela Thompson the Northeast Catchment Manager along with Andrew Garner and Craig Grimshaw.

The weather on the day was warm with no rain having fallen for several days.



The inlet screen had no gaps or breaks, however as shown it does appear that they can be bent when under pressure, NRW would suggest a more robust screen be added to the inlet to prevent solids being passed forward which could affect treatment.



The primary sludge tank appeared to be In good working order, at the time of NRW's visit only one was operating.



Primary tanks and sludge boards were free of fungus and growth.



Filter beds had minor growth on the surface, this should be kept clear as possible to prevent impact on efficiency.



the final settlement tank had a minor crack in the structure, the surface area around the tank was dry with no clear or obvious signs of water saturation however NRW would request that this is fixed without delay to prevent any water going to ground.

Unfortunately, on the day it was not possible to inspect the outfall due to health and safety concerns in reaching the area.

The water leaving the site appeared to be clear.
