4. Details of our assessment

Morfa Non-Hazardous Landfill - Site Description

Tata Steel UK Limited (Tata) operates the Morfa Non-Hazardous Landfill (MNHL) in accordance with Permit BV7311IE. The larger waste management site at Port Talbot includes the unlined Closed Landfill (MCL) and the Hazardous Landfill (MHL).

The non-hazardous wastes mainly comprise of steel slag, with flue dusts, water treatment solids, office waste, canteen wastes and demolition rubble arising from steel production at Port Talbot.

Purpose of Compliance Assessment

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

1. Q1 2023 Monitoring Returns

1. **Q1 2023 Monitoring Returns**

The operator submitted the Q1 2023 monitoring returns on the 27th April 2023, which is within the specified reporting window, representing compliance with the permit condition (4.2.3).

Groundwater Monitoring

Over the reporting period the required groundwater monitoring; ground water level and quality, was undertaken.

The reported results were compliant with the Arsenic (50 (µg/l)) and Chloride (250 (mg/l)) trigger levels.

Leachate Monitoring

Leachate level monitoring was undertaken to the frequency required by the permit (weekly). Leachate levels in all wells were compliant throughout the monitoring period, with no breach of the 1m limit recorded.

Leachate quality monitoring, as required by Table S3.6 of the permit was undertaken, and the relevant data submitted.

Surface Water Monitoring

The required surface water monitoring for the quarter was undertaken and the relevant data submitted.

Water levels at each surface water monitoring point throughout the landfill and the neighbouring Margam Moors were measured monthly, as required by the permit.

Landfill Gas Monitoring

Quarterly landfill Gas monitoring was undertaken for the external monitoring wells with no exceedances in

the Methane limit detected.

Monitoring data was not provided for GA7 or GA16, with the two external gas wells requiring replacement.

Recharge Trenches

The recharge trenches have yet to be constructed. Water level and quality data will be required monthly following the construction of each trench.
