4. Details of our assessment

DCWW responded to CAR_NRW0041651 on the 2/5/23

DCWW have evidenced that the spills on 2/8/22, 24/8/22, 26/8/22, 12/9/22 and 30/9/22 were because of multiple pump failure and failure of the rising main at the SPS. These are

in line in with conditions of the emergency spill permit CG0351701.

Condition 4.3.1 states "Natural Resources Wales shall be notified as soon as reasonably practicable following detection, within the site of the regulated facility of any malfunction, breakdown or failure of equipment or techniques, accident, or emission of a substance not controlled by an emission limit which has caused, is causing or may cause significant pollution. Any other significant adverse environmental effects, which may have been caused by the activity, shall also be notified to Natural Resources Wales as soon as reasonably practicable following detection."

DCWW did not submit an OPNOT notifying NRW of the pump failures at the SPS until 27/10/22 and that is not considered to be "as soon as reasonably practicable following detection" which would have been on 2/8/22 according to a diary entry shared by DCWW. This has been scored as a CAT4 breach of condition 4.3.1 and Natural Resources Wales issue a warning as the enforcement response for the breach.
