4. Details of our assessment

DCWW responded to CAR_NRW0041651 on the 2/5/23

DCWW have evidenced that the spills on 2/8/22, 24/8/22, 26/8/22, 12/9/22 and 30/9/22 were because of multiple pump failure and failure of the rising main at the SPS. These are

in line in with conditions of the emergency spill permit.

Condition 7 of the consent states:

“On any occasion when operation of the emergency overflow occurs the discharger shall notify the Local Authority Environmental Health Officer by telephone/telefax as soon as practicable and confirm in writing within 14 days of the occurrence.”

This was not done and therefore is a CAT4 breach of the permit. Natural Resources Wales issues a warning in response to the breach.
