Thank you very much for your time during my visit on the 29/11/2018. Despite operation of the site for several years, this is the first inspection from Natural Resources Wales. I was extremely impressed with the infrastructure and operations on site. There were however non-compliances, most of which are paper work and record related. There are several documents which you know have been created by your consultant and submitted to Natural Resources Wales but were not in the site office during the inspection. Could you please ensure the following documents are available in the site office ASAP and are followed at all times:

1. Accident Management Plan
2. Raw Materials List
3. Inspection & Maintenance Log
4. Site Closure Plan
5. Odour Management Plan
6. Noise Management Plan

The current Site Entrance Identification Notice does not include all the necessary information. The site identification notice should be easily readable from outside the site in daylight hours and should include the:

- emergency contact name and telephone number of the permit holder and/or operator.
- statement that the site is permitted by Natural Resources Wales.
- permit number.
- Natural Resources Wales general enquiries and incident number 0300 065 3000.

As discussed on site, please also ensure that all chemicals on site are placed within a bunded structure and please consider collision barriers around the vulnerable sides of the feed silos.

Thanks again for your time in showing me around. Please ensure all the requirements above are followed ASAP. As this is your first visit from Natural Resources Wales the non-compliances have not been scored as breaches, however we expect all paperwork to be fully in place with immediate effect.
